UNROOTED DORMANT GRAPEVINE CUTTINGS

- Size 1. Standard Field/Nursery cutting. 4-10mm thickness below top bud. 1 cutting = 3 buds minimum.
- Size 2. Bench grafting/Chip budding cutting. 4-10mm thickness below top bud, 1 cutting = 4 buds minimum.
- Size 3. Top working budding cutting. 5-12mm thickness below top bud, 1 cutting = 4 buds minimum
